By signing this agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of your participation in the Altavista Area Y Programs, now or at any time in the future.

Acknowledgment of Risk

I hereby acknowledge and agree that participation in aquatic activities (including but not limited to water fitness, swim lessons, lap swim, open and family swim) comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with participation in aquatic activities as described above, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with aquatic activities as described above, participation and that said list in no way limits the operation of this Agreement.

Coronavirus / COVID-19 Warning & Disclaimer

Initial

In consideration of my participation in aquatic activities as described above I, the undersigned participant, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to my aquatic activities as described above participation.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in aquatic activities as described above participation and that I am voluntarily assuming said risks. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, illness or death, I sustain while participating in aquatic activities as described above and that by signing this agreement I HEREBY RELEASE Releasees from all liability for such loss, damage, or death. I further certify that I am in good health and that I have no conditions or impairments which would preclude my safe participation aquatic activities as described above.
